1. ABOUT IIITDM KURNOOL:

Indian Institute of Information Technology Design and Manufacturing (IIITDM) Kurnool is an Institute of National Importance under the Ministry of Education, Government of India. It is established in 2015, and aimed to become a Centre of Excellence for pursuing Design and Manufacturing oriented Engineering Education and Research domains.

Currently, the Institute is offering four (4) B. Tech. programmes in Computer Science and Engineering (CSE), Artificial Intelligence and Data Science (AI&DS), Electronics and Communication Engineering (ECE), and Mechanical Engineering (ME), three (3) B. Tech Dual Degree Programmes in CSE, ECE & ME, and Seven (7) M. Tech. programmes in Departments of Computer Science and Engineering (CSE), Electronics and Communication Engineering (ECE), and Mechanical Engineering (ECE), and Mechanical Engineering (CSE),

Ph.D. programmes, in Science and Engineering departments are being offered, in frontier research areas under the guidance of experienced faculty.

2. PROGRAMS OFFERED:

- 1. Ph.D. in Computer Science and Engineering
- 2. Ph.D. in Electronics and Communication Engineering
- 3. Ph.D. in Mechanical Engineering
- 4. Ph.D. in Sciences (Physics / Mathematics / English)
- 5. Interdisciplinary PhD Program (Full-Time Ph.D. with MoE Fellowship)

3. CATEGORY OF ADMISSION

a) Full-Time Ph.D.

- i) Regular Full-Time Program with MoE Fellowship HTRA
- Regular Full-Time Program with Financial Support from Sponsored Project / External Funding Scheme from Govt. (DST/UGC/CSIR/DRDO/NBHM, etc.)

b) Part-Time Ph.D.

- For permanent employees of Government R&D labs, educational institutions, Govt. Organizations, Govt. industry, PSUs/State undertakings.
- For employees of Private Organization/Industry/Educational Institutions, with at least 3 years standing (i.e., established at least five years before 2 the last date of applying for Ph.D. (Part-time) admission as per the advertisement) with membership in CII/ASSOCHEM or any other equivalent membership.
- iii) Regular Staff of IIITDM Kurnool with at least 3 years of experience

The number of vacancies published in department brochure is tentative and may increase or decrease at sole discretion of IIITDM Kurnool.

4. Highlights of IIITDM Kurnool:

- 1. State-of-the-art research facilities and laboratories available
- 2. MoU with C.R.Rao AIMSCS for Research collaborations
- 3. Financial support for Rs. 2 Lakhs for attending National/International conferences during the PhD period for regular PhD Scholars (MoE fellowship)
- 4. Well-stocked library with digital resources

- 5. Hostels with essential amenities for students
- 6. Sports facilities for physical activities and recreation

4. FINANCIAL ASSISTANCE:

4.1. Ph.D. Admission (Under MoE Fellowship/HTRA):

Scholars under the HTRA category are eligible for Half-Time Research Assistantship (HTRA) provided by the Institute under the following regulations:

a) The scholars need to carry out Teaching Assistantship (TA) for at least 8 hours per week.

b) Renewal of assistantship for every subsequent semester will be contingent on enrolment, satisfactory progress in research work, and good performance during the preceding semester.

1st and 2nd Year (JRF): 37,000/- & 3rd - 5th Year (SRF*): 42,000/-

Financial assistance and HRA are provided to selected scholars based on the prescribed rules of MoE and Institute rules respectively.

*Upgradation from JRF to SRF is based on the assessment and recommendations of the Doctoral Committee.

4.2. Ph.D. Admission (Under Sponsored Project):

Scholars admitted under Project category are eligible for an assistantship from Sponsored Research project under regulations of the respective Project agency (DST/SERB/CSIR/DRDO etc.,). The admission to this category is contingent upon the successful selection of the candidate for Project.

Research Scholars under the Sponsored Project get fellowship from respective project.

4.3: PhD scholars enrolled in a sponsored project for a period of 2.5 years or more, are entitled to financial assistance (by Institute) additionally for one more year.

4.4: HRA: Housing Rent Allowance at 10% will be granted to married scholars who are not using hostel facilities and are living off-campus.

4.5: Allowing one overseas international conference presentation to **regular Ph.D. scholars** (MoE Fellowship) during their entire Ph.D. tenure towards presenting their research work with financial support from institute up to INR 1.5 Lakhs for Group B countries and up to INR 2 lakhs for Group-A countries.

5. APPLICATION PROCEDURE:

Interested and eligible candidates shall submit an online application using the portal available on the Institute website (www.iiitk.ac.in). Enclosures such as GATE score card/ CSIR-UGC-JRF, Educational and Experience certificates, online fee payment receipt, No Objection Certificate (NOC) and sponsorship/undertaking certificate in support of application are to be uploaded as separate documents (pdf), along with the application form. In case, NOC and Undertaking Certificate is not enclosed at the time of online submission, a duly-signed self-declaration form should be uploaded by the candidate stating that NOC and Undertaking Certificate will be submitted at the time of interview. After filling the form, applicants are advised to take a printout of their application and keep the same for future record.

Application Fee:

Gen/OBC/EWS candidates: Rs.500/-

SC/ST/PwD candidates: Rs.250/-Candidates need to pay application fee only through online mode and the details are as follows.

Note: It is instructed to keep one copy of payment proof for future reference.

Shortlisted candidates qualified for the Written test/Interview need to submit the following self-attested documents. **Original certificates** are to be produced for verification on the day of Written test / Interview:

- a) Copies of all Mark/grade cards, degree certificates beginning from SSLC/SSC towards proof of qualification with original certificates.
- b) Copy of latest Community Certificate in the case of SC/ST/OBC/Economically Weaker Section (EWS) candidates issued by the competent authority of respective State Government.

- c) Authorized Doctor's Certificate with disability descriptions in the case of Person with Disabled (PwD) candidates.
- d) Copy of GATE or CSIR UGC-JRF/NET/JEST/Inspire fellowship or any other fellowship awarded if any.
- e) Copy of proof of Experience certificate, if any.
- f) Copy of No Objection Certificate (Annexure B) and Sponsorship certificate (Annexure C), if any.

6. SELECTION PROCEDURE

- a) Respective Departments will conduct the shortlisting and selection process.
- b) Eligible candidates possessing the minimum educational qualifications and satisfying additional criteria set by the institute from time to time only will be called for the written test and/or Interview.
- c) Based on the academic record and the performance of the candidates in the written test and/or Interview test, the selection committee will finalize the applicants for admission to the Ph.D. programme.
- d) The syllabus for the written test and/ or Interview is GATE 2025 syllabus in respective subject.

7. RESERVATION OF SEATS:

Reservations are applicable as per the rules and regulation of the Govt. of India. 5% relaxation for the educational qualification for SC/ST candidates will be applicable.

8. FEE STRUCTURE:

The Fee structure for the Ph. D. programme is given in Annexure 'A'.
