General Information and Instructions:

1. Applications are invited from Indian nationals for recruitment to the post of Registrar.
2. Candidates are required to satisfy themselves, before applying that they possess the minimum essential qualifications, experience, etc., as laid down in the advertisement.
3. Applicants are required to submit applications only using the online recruitment portal available on the Institute website (www.iiitk.ac.in). Applications cannot be submitted by post. The last date for submission of online application will be **27.05.2025**.
4. Applications received after the due date/time will be summarily rejected.
5. All qualifications, experience and age limit will be considered as on **27.05.2025**.
6. Persons employed in Government/Semi-Government Organization or Government Educational Institution must enclose NO OBJECTION CERTIFICATE along with online application. In case NOC is not enclosed, the candidate can submit a self-declaration stating that NOC will be submitted at the time of interview (as per format provided).
7. The Institute reserves the right to evolve any screening/selection process at the sole discretion of the Director, IIITDM Kurnool, such as written test/interview etc., if the number of applicants is large for the post.
8. Mere fulfilment of minimum qualifications and experience requirement does not entitle the candidate to be called for an interview.
9. Canvassing in any manner would entail disqualification of the candidates.
10. The candidate is responsible for the correctness of the information provided in the application. If it is found at a later stage that any information given in the application is incorrect/false, his/her candidature will be cancelled and further, the candidate is liable for criminal action.
11. The Institute reserves the right to modify/defer/cancel the advertisement/recruitment process at any stage without assigning any reason.
12. The list of shortlisted candidates for interview will be displayed on the website of the Institute. No individual communications will be sent. Candidates are advised to visit the Institute website regularly.
13. The candidates are required to provide one email id and a mobile number for communication during the entire selection process.
14. Travelling allowance will be paid for attending the interview (economy air travel/AC-II Train), if conducted in person.

16. SC/ST/PwD/Women/Ex-Servicemen candidates are exempted from payment of application fee.
17. Only serious candidates need to apply, and he/she should be able to join the Post at the earliest (preferably within a month) once an offer is made
