Indian Knowledge Systems (IKS) under the Ministry of Education, Govt. of India has sanctioned the project entitled "Nyayashaastras for Computer Science Engineers" under the Scheme IKS Institutional Internship Program-2025.

Computer Science and Engineering is one of the disciplines where predominantly all the subjects are built over logic. Traditionally, it is the Greek or the western logic that is used. For Traditional Scholars: Should have basic knowledge of Tarka Shastras (At least till Muktavali); Should have basics of Mathematics at least till 10th. Since this involves mathematics and logic, scholars who work on this are expected to have a strong logical foundation to think logically. Irrespective of Scholars or Engineers, both should have strong commitment and zeal towards contributing to our culture, values and scriptures.

Tenure of appointment: The paid internship is only till the end of Feb 2026. However, if the interns are interested, they are allowed to extend, without a guarantee of Internship stipend based on the performance.

Mode of Selection: The selection process consists of an Online Interview.

1. Instructions to the Applicants:

- a) The posts are on a purely temporary basis.
- b) Candidates are required to carefully go through the details of qualifications, experience, and instructions available on the Institute website. They should satisfy themselves, before applying that they possess at least the minimum essential qualifications, work experience etc. as laid down in the advertisement.
- c) Incomplete/ partially filled offline applications and CVs will not be considered.
- d) No correspondence by any means will be entertained from candidates regarding postal delays, conduct & result of interview, reasons for not being called for interview.
- e) The Institute reserves the right to shortlist only the candidates whose candidature matches with relevant work experience for the smooth execution of this project.
- f) The decision of the Institute in all matters will be final and no correspondence whatsoever will be entertained from the candidates.

- s) Important: Students who are currently pursuing B.Tech should get a No-Objection Certificate from their HoDs or Competent Authorities. Applications without a No-Objection Certificate will be rejected without any correspondence. However, for students who are studying in IIITDM Kurnool and applicants applying under scholar category, both are exempt from NOC certificates.

Candidates who are interested in internship without funding can apply any time. However, there are three cohorts for shortlisting for interns with funding:
