### 1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

#### 2. Generic

#### 3. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

1) Payment of wages shall be as per the Minimum Wages notified by Office of Chief labour Commissioner ( C), Ministry of Labour & Employment, Govt. of India or for special works, extant Govt. Norms/BoG direction s shall be followed.

2) Existing Manpower (68 Nos.) deployed by existing contractor may be continued subject to requisite doc umentation & other details pertaining to EPF/ESI/Police verifications and other formalities and confirmation from the Institute on the suitability of the candidate.

3) Duration of Contract: The contract shall be initially for 1 year. However, the contract may be renewed o n satisfactory performance and mutually agreed-upon terms. In case of unsatisfactory performance, the co ntract will be terminated by giving one-month notice even before the expiry of 1 year. The tentative date o f commencement of the Contract starts from 01.04.2025.

4) Bidders shall quote their bid, as per the values (Wages, ESI, EPF etc.) given in the bid. Monthly payment s will be made on actual services rendered.

5) It is generally observed that prospective bidders submit/ upload desired documents in duplicate or tripli cate or submit un- wanted/irrelevant documents with the bid which lead to confusion and there might be c hances of skip/ over-look desired document while evaluation because of huge volume of un-wanted papers . Therefore, it is instructed to submit only desired/ relevant documents as per the requirement/eligibility cr iteria/terms &conditions mentioned in the bid. In case of non-compliance, Institute shall be compelled to re ject/ disqualify the bidder and no representation/ clarification shall be entertained.

6) The Bidders shall have to comply with all the given requirements/terms & conditions mentioned in the bid including those mentioned in the "Buyer added Bid specific terms & conditions" and Sco pe of Work.

7) The Bidders shall have to comply with all the preliminary & eligibility criteria including those me ntioned in the Buyer added bid specific ATC.

8) The bidders are advised to visit the Institute for understanding the geographical location.

9) Performance Security shall be submitted only in the form of Bank Guarantee or Bankers Cheque/Deman d Draft.

10) Queries if any may be raised on GeM only.

11) The Director, IIITDM Kurnool reserves the right to accept/ reject any or all the bids without assigning a ny reason. Any attempt on the part of any company/ organization/firm to influence or negotiate directly or indirectly with the Institute will lead to exclusion from consideration. The decision of the Institute in this re gard shall be final.

12) Wages are generally to be made by 5th of the corresponding month and in no circumstances be delay ed beyond 7th of the month. Payment of wages & statutory payments should be made as per applicable ti melines irrespective of settlement of bills.

13) Payment with be made within 15 days of submission of bills along with all necessary documents/attach ments including copies of proof of payments with respect to ESI/EPF/GST/Salary payments and disbursal of Salary slips duly signed by manpower. Bills may be initially submitted excluding ESI/EPF/GST payment pro of, however, by 15th the same shall be sent through email. Only after receipt of this, bill will be approved and settled.

# Disclaimer/अस्वीकरण

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

पर प्रतिबंध के संबंध में भारत के साथ भूमि सीमा साझा करने वाले देश का कोई भी बिडर इस निविदा में बिड देने के लिए तभी पात्र होगा जब वह बिड देने वाला सक्षम प्राधिकारी के पास पंजीकृत हो।बिड में भाग लेते समय बिडर को इसका अनुपालन करना होगा और कोई भी गलत घोषणा किए जाने व इसका अनुपालन न करने पर अनुबंध को तत्काल समाप्त करने और कानून के अनुसार आगे की कानूनी कार्रवाई का आधार होगा।
