1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

2. Generic

Buyer Organization specific Integrity Pact shall have to be complied by all bidders. Bidders shall have to upload scanned copy of signed integrity pact as per Buyer organizations policy along with bid. [Click here to view the file](#)

3. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

1) Payment of wages shall be as per the Minimum Wages notified by Office of Chief labour Commissioner (C), Ministry of Labour & Employment, Govt. of India or for special works, extant Govt. Norms/BoG directions shall be followed.

2) Existing Manpower (68 Nos.) deployed by existing contractor may be continued subject to requisite documentation & other details pertaining to EPF/ESI/Police verifications and other formalities and confirmation from the Institute on the suitability of the candidate.

3) Duration of Contract: The contract shall be initially for 1 year. However, the contract may be renewed on satisfactory performance and mutually agreed-upon terms. In case of unsatisfactory performance, the contract will be terminated by giving one-month notice even before the expiry of 1 year. The tentative date of commencement of the Contract starts from 01.04.2025.

4) Bidders shall quote their bid, as per the values (Wages, ESI, EPF etc.) given in the bid. Monthly payments will be made on actual services rendered.

5) It is generally observed that prospective bidders submit/ upload desired documents in duplicate or triplicate or submit un-wanted/irrelevant documents with the bid which lead to confusion and there might be chances of skip/ over-look desired document while evaluation because of huge volume of un-wanted papers. Therefore, it is instructed to submit only desired/ relevant documents as per the requirement/eligibility criteria/terms & conditions mentioned in the bid. In case of non-compliance, Institute shall be compelled to reject/ disqualify the bidder and no representation/ clarification shall be entertained.

6) The Bidders shall have to comply with all the given requirements/terms & conditions mentioned in the bid including those mentioned in the "Buyer added Bid specific terms & conditions" and Scope of Work.

7) The Bidders shall have to comply with all the preliminary & eligibility criteria including those mentioned in the Buyer added bid specific ATC.

8) The bidders are advised to visit the Institute for understanding the geographical location.

9) Performance Security shall be submitted only in the form of Bank Guarantee or Bankers Cheque/Demand Draft.

10) Queries if any may be raised on GeM only.

11) The Director, IIITDM Kurnool reserves the right to accept/ reject any or all the bids without assigning any reason. Any attempt on the part of any company/ organization/firm to influence or negotiate directly or indirectly with the Institute will lead to exclusion from consideration. The decision of the Institute in this regard shall be final.

12) Wages are generally to be made by 5th of the corresponding month and in no circumstances be delayed beyond 7th of the month. Payment of wages & statutory payments should be made as per applicable timelines irrespective of settlement of bills.

13) Payment will be made within 15 days of submission of bills along with all necessary documents/attachments including copies of proof of payments with respect to ESI/EPF/GST/Salary payments and disbursement of Salary slips duly signed by manpower. Bills may be initially submitted excluding ESI/EPF/GST payment proof, however, by 15th the same shall be sent through email. Only after receipt of this, bill will be approved and settled.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.

15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.

This Bid is governed by the [General Terms and Conditions/सामान्य नियम और शर्तें](#), conditions stipulated in Bid and [Service Level Agreement](#) specific to this Service as provided in the Marketplace. While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the laws./जेम की सामान्य शर्तों के खंड 26 के संदर्भ में भारत के साथ भूमि सीमा साझा करने वाले देश के बिडर से खरीद
