## Open Tender for Empanelment of Vendor for Supply of Books/Other Printed Documents at IIITDM Kurnool

IIITDM Kurnool, invites quotation through Open tender in the prescribed format given in the tender document, from reputed Vendors/Distributors for "<u>Empanelment of Vendor for Supply of Books/Other Printed Documents at</u> IIITDM Kurnool Library". This vendor ship will be valid for two years. Tenders are invited under the two bid system i.e. Technical Bid and Financial Bid (in terms of discount offerings). The Technical Bid will be opened first. In the second stage, Financial Bid from the vendors who qualifies the Technical Bid will be opened for further evaluation and selection towards empanelment. Interested vendors may send the completed application form along with the requisite documents to "The Registrar, Indian Institute of Information Technology Design And Manufacturing Kurnool, Jagannathagattu, Dinnedevarapadu, Kurnool-518008,Andhra Pradesh, India".

Instructions for bidders, detailed terms and conditions, application proforma for technical bid and data sheet for financial bid are as under:

### 1. Instructions for bidders:

- The tenders are invited under two bid system i.e. Technical Bid and Financial Bid (in terms of discount offerings).
- Interested vendors should submit one main envelope called Master Envelope, and two separate envelopes, called Envelope I and Envelope II.
- Envelope I should be super scribed as "Technical Bid for Vendor Registration and Empanelment for Supply of Books, other Documents such as CDs/DVDs/Audio-Visual Materials to IIITDM Kurnool". All the tender documents, which includes Annexure I, Annexure II, together with all relevant encloses, should be kept in Envelope I and sealed.
- Envelope II should be super scribed as "Financial Bid for Vendor Registration and Empanelment for Supply of Books, other Documents such as CDs/DVDs/Audio-Visual Materials to IIITDM Kurnool". The Financial Bid (Annexure III) should be kept in Envelope II and sealed.
- The Master Envelope should be super scribed as "Vendor Registration and Empanelment for Supply of Books, other Documents such as CDs/DVDs/Audio-Visual Materials to IIITDM Kurnool". The Envelope I and Envelope II should be kept in Master Envelope and sealed.
- All the documents in Envelope I and Envelope II should be duly signed by the vendor or by an authorized person, giving his\her Full Name, Designation, Email Id, and Mobile Number. Further, official seal of the firm should be put together with signature on all the pages.
- Incomplete and conditional tenders will be rejected. Quoting unrealistic rates will lead to disqualification. The decision of the Director will be final in this regard.
- If, at any point of time, any of the document furnished by the vendors/suppliers is found to be false, it would be deemed a breach of terms of contract making the firm concerned liable for legal action besides termination of empanelment.
- No bidders will be allowed to withdraw after submission of bids/opening of the tender. Failing to maintain this discipline, the bidding vendors are liable to be black-listed by the institute.
- Any tender received after due date and time will not be considered.
- The Vendor(s)/ Supplier(s) short-listed for vendor empanelment are required to strictly agree to supply as per the institute's "Terms & Conditions for Acquisition of Books" as stipulated hereunder.
- The tenderers whose technical bids are accepted /qualified will be informed about the date and time of opening of financial bids.

## 2. <u>The empanelment will be governed by the following 'Terms and Conditions':</u>

## 3.1 General:

- The Director, IIITDMKurnool, reserves the right to approve or reject any or all the vendor, whose decision will be final in all cases in respect of acceptance/rejection/arbitration.
- IIITDMKurnool, does not bind itself to add in approved list of vendors or to place the purchase order to any of the vendor.

## **3.2 Security Deposit:**

- Qualified vendors (both in technical and financial bid) shall submit a security deposit of Rs.25,000/- (Twenty Five thousand only) vide demand draft, in favor the Director,Indian Institute of Information Technology Design and Manufacturing Kurnool within five (05) days of confirming vendor empanelment.
- The above security deposit will be refunded to the vendors only on successful completion of the duration of empanelment i.e., two years from the date of commencement of empanelment.

### 3.3 Enquiry on availability of books:

- The library may place an enquiry with all the empanelled vendors for the required titles and number of copies of each thereof, by email.
- Within two days of receipt of the email, the Vendors having books as per above list in their ready stock of books have to respond within stipulated time quoting titles available with number of copies and unit price, by reply email only.

## 3.4 Purchase Orders:

- Supply of books has to be made strictly against the purchase orders.
- Sending the acknowledgement of the receipt of purchase order, which is taken as acceptance of the purchase order, is mandatory, preferably by email.
- Any clarification/query regarding the purchase order should be sought from the Library within two (02) Days of receipt of the order.

## 3.5 Supply:

- The supply should be free of freight charges.
- If the supply is made through Railway Parcel, in that case the freight must be pre-paid.
- If the supply is made by post, the books should be sent by registered post/parcel or courier, whose charges will be borne by the supplier. Books sent via V.P.P. will not be accepted.
- Every supply should be accompanied by a delivery Challan, clearly bearing the details of the items and titles in supply, their quantity and price.
- 90% of the books from list of books mentioned in the PO should be supplied within the stipulated period, failing which 2% penalty will be imposed (Penalty based on book cost).

## **3.6 Timeframe for supply, and cancellations:**

- Four (04) weeks (maximum) for Indian titles
- Eight (08) weeks (maximum) for Foreign titles
- After the expiry of timeframe, the purchase order automatically stands cancelled.

### 3.7 Edition specifications:

- Pirated Books strictly prohibited and supply of such books may lead to immediate ban from empanelment.
- Latest editions of books must be supplied, unless mentioned otherwise.
- By default, paperback editions of books should be supplied, unless specified otherwise.
- By default, Indian editions of books should be supplied, unless mentioned otherwise.
- In case of unavailability of paperback and Indian editions, clarification/permission should be sought, preferably by email, from the Library, regarding supply of the available editions in lieu of the default.

### 3.8 Invoicing procedure:

- Pre-receipted invoice(s)/bill(s) are to be submitted in triplicate (3 copies).
- A revenue stamp should be affixed on the original bill and should be signed by authorized signatory.
- Invoice should be raised in favor of The Director, IIITDM Kurnool, Jagannathagattu, Dinnedevarapadu, Kurnool-518008, Andhra Pradesh, India.
- One invoice should be raised against one purchase order (P.O.) only. Titles from different P.O.s should not be combined and supplied under one invoice.

## **3.9 Undertaking: Every invoice should certify the following:**

- The prices charged in this invoice are the actual, current publisher's prices as billed to us, and are true and correct.
- The prices charged are as per the publisher's invoice (publishers/importers/distributors) and latest catalogue.
- The latest editions are supplied..
- The books supplied against this order have been checked against defects in collation, binding, and condition of accompanying material viz., CDs etc., and for other physical conditions. If any defects are detected later, the defective books will be replaced by us free of cost, at the destination of supply.

## 3.10 Mandatory enclosures with invoice:

- A copy of publisher's invoice as a price proof without any cuttings.
- Mandatory to follow RBI conversion rate.
- Every price proof and currency conversion proof should contain seal and authorized signature of the vendor.

### 3.11 Discount:

- The percentage of Discount finalized by the Component Authority for various categories shall remain in force during the currency of Empanelment.
- It may be specifically noted that no changes in the accepted rates shall be allowed during currency of empanelment.
- Discount will be fixed on the basis of technically qualified bidders quote.

### 3.12 Conversion Rates:

- The prices in the invoice should be indicated in original currencies.
- Reserve Bank of India (RBI) currency conversion rates as applicable on the date of the purchase order should only be followed, and should also be clearly indicated on the invoice.
- **3.** Termination of registration and delisting from the panel: A vendor's registration may be terminated/dropped/black-listed from the list of registered suppliers at the occurrence of any of the following event:
- If the vendor fails to deliver even, at least 75% of the supply (in terms of number of titles) during the year.
- In case of breach of any terms of agreement, or unsatisfactory/inefficient working on the part of the vendor.
- If at any time it is found that the information provided by the vendor in any form about publications, services and related matters are incorrect and result in losses in any form to the Institute.
- In such case(s), the institute will be at liberty to cancel the registration without giving any Prior notice to the vendor, and the Institute reserves the right to forfeit the security deposit, or the amount of loss occurred to the Institute, from the available invoices submitted by that vendor.

- **4.** The Institute reserves the right to change or modify or amend or substitute any clause in the terms and conditions that are listed above if required, at any time.
- 5. All disputes and differences arising out or concerning the work shall be subject to the sole arbitration of The Director, IIITDM KURNOOL or his nominee. The decision of the arbitration shall be final & binding on both the parties. The empanelment will be interpreted under Indian Laws and disputes adjustable within Courts of Laws under jurisdiction of Kurnool Courts.
