1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

2. Generic

Buyer Organization specific Integrity Pact shall have to be complied by all bidders. Bidders shall have to upload scanned copy of signed integrity pact as per Buyer organizations policy along with bid. [Click here to view the file](#)

3. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

A) Instructions to Bidders:

1) Bids are invited for Providing Mess Services in the Hostel Mess independently **for approximately 600 (minimum 400 and max. 700) students at Akshaya Dining Hall, Block-A, IIITDM Kurnool, Kurnool, A ndhra Pradesh and approximately 600 (minimum 500 and max. 800) students at Akshaya Dining Hall, Block-B, IIITDM Kurnool, Kurnool, Andhra Pradesh. Schedule-1 for Block-A and Schedule-2 for Block-B.**

2) The strength of the students shall be subject to option availed by the students among the two Mess (Block A & Block B). The mode of availing of option shall be as decided by the Hall Management Committee. Students shall exercise their option for either Mess Block A or Mess Block B prior to commencement of each month. Allocation shall be done based on student preference subject to Minimum assured strength of each Block; and Maximum permissible capacity. Once the maximum limit of one Block is reached, remaining students shall be allotted to the other Block. The Institute assures a minimum of 400 students for Block A and 500 students for Block B. However, the actual number may vary month to month subject to the maximum capacity.

3) The Contractor acknowledges that student strength may fluctuate monthly and agrees that no claim shall lie against the Institute on account of such variation within the minimum and maximum limits specified.

4) Bidders have to **quote the prices inclusive of GST considering 600 students for a period of one year**. However, payment will be as per the per day per person price based on the actual services availed as per the terms & conditions of the bid.

5) **Institute intends to engage two independent contractors for operating Mess Block-A and Mess Block-B of Akshaya Dining Hall, Kurnool, Andhra Pradesh** in order to maintain competition in quality and service standards. **In case same bidder stands Lowest (L1) for both the schedules, they will be given an opportunity for opting either of the schedule (Block-A or Block-B) through way of seeking price justification. After opting of a certain Schedule (Block), their bid in the other Schedule (Block) will be rejected and the next qualified bidder shall be eligible for award of contract. The decision of the Institute in this regard shall be final and binding and shall not be open to challenge.**

6) **Contract Period:** The contract is initially for a period of Twelve Months, which may be extended further for a period of 12 Months or part thereof, subject to satisfactory performance of the work and the requirement of the Institute. The decision of IIITDM Kurnool in this regard will be final.

7) **Pre-Bid Meeting:** Bidders are invited to attend the pre-bid meeting in Hybrid Mode on **23.02.2026 at 03:00 PM**. However, bidders are advised to visit in person for the pre-bid meeting at Mini Conference Room, IIITDM Kurnool, Jagannathagattu, Kurnool, Andhra Pradesh-518008. Prior Intimation email with details of the persons visiting along with attested copy of their ID proof shall be sent to purchase@iiitk.ac.in with a copy to registrar@iiitk.ac.in and chiefwarden@iiitk.ac.in.

8) Queries if any may be raised on GeM only. No email queries will be entertained.

9) **Approx. Student strength of IIITDM Kurnool is 1200 Nos. Bids are invited for two separate mess blocks (A&B) as Schedule 1 & 2 with estimated student strength of 600 each and bidders are required to submit their bids, considering student strength of 600 for each schedule. However, actual payment will be as per the actual utilization by the students based on options availed and subject to allowed strength.**

10) Avoid submitting the same document multiple times.

11) Bidders are hereby instructed to check the preliminary criteria & eligibility criteria as mentioned in Buyer uploaded ATC document and to Give number to every document submitted and refer the same in the Eligibility criteria compliance statement and in the proforma for "Profile of the Bidder".

B) Upon Award of the Order/Contract, the successful bidder must:

1) Obtain the FSSAI Certificate and all other statutory permissions/licenses as applicable and submit the same to the Institute within 15 days. In case of non-compliance, the contractor on whom the order/contract is placed shall be liable for any consequences including and not limited to withholding of bills.

2) Submit Performance Security of 3% of contract value.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.

7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers/Service Providers shall ensure full compliance with all applicable labour laws, including the provisions, rules, schemes and guidelines under the four Labour Codes i.e. the Code on Wages, 2019; the Industrial Relations Code, 2020; the Occupational Safety, Health and Working Conditions Code, 2020; and the Code on Social Security, 2020 as and when notified and brought into force by the Government of India.
